

Citadel Hockey Player Contract

Each player must read the policies contained in the *Player Contract* and initial and sign where indicated to acknowledge the player's understanding and acceptance of these policies. The form must then be returned to the coach at the first team practice.

Initial Here

___ I hereby agree to pay the The Citadel Hockey Club, 171 Moultrie St., Charleston, SC 29409, the cost to participate in hockey in the following amounts and manner: \$800 payable by semester in two increments of \$400. I also understand that no refunds will be given due to suspension or termination of a player for disciplinary reasons. No refunds will be given for a voluntary withdrawal from the program. Any Player sustaining a season ending or extended injury (over 60 days) while participating in a sanctioned event may be eligible for a pro-rating of fees. Failure to pay fees may be a breach of The Citadel Honor Code.

___ I understand and accept the importance of practice and game attendance and will make every reasonable effort to attend all scheduled practices and games and to notify my head coach in **advance** if I cannot attend a practice or game. I also understand that by missing practices my game time may be adversely affected.

___ I understand and accept that the coach may not give all players an equal amount of playing time and that decisions about playing time are at the sole discretion of the coaching staff.

___ I hereby agree to cooperate with the The Citadel Hockey Club and participate in any and all reasonable promotional activities of the Club which will, in the opinion of the Club, promote the welfare of the Club. This will include fundraising activities.

___ I agree to to conduct myself on and off the rink according to the highest standards of honesty, morality, fair play and sportsmanship, and to refrain from conduct detrimental to the best interest of the The Citadel Hockey Club and The Citadel.

___ I understand that The Citadel Hockey Club may terminate this Contract upon written notice to the Player if the Player shall at anytime fail, refuse, or neglect to obey the Club' rules governing training and conduct of players, such failure, refusal or neglect should constitute a material breach of this Contract.

____ I understand that all jerseys, shells and socks are owned by The Citadel Hockey Club and must be returned on departure from the club or at the end of the season. Failure to return jerseys can result in a \$100 per jersey charge to your quartermaster account and/or being charged with an honor violation. Failure to return shells can result in a \$75 charge to your quartermaster account and/or being charged with an honor violation. Failure to return socks can result in a \$25 charge to your quartermaster account and/or being charged with an honor violation.

____ I understand that the team can only carry 18 skaters and 2 goalies (Playing Squad). In the event that more than 18 skaters and 2 goalies try out for the team not everyone will be on the Playing Squad. These players (Reserve Squad) will be allowed to attend practice. The Reserve Squad will have their dues reduced to \$200 per semester. In the event of injury or other reason a player on the Playing Squad cannot make a game or games, players on the Reserve Squad can move up to the Playing Squad at the coaches discretion. In the event you move up from the Reserve Squad to the Playing Squad your fees will be \$20 per game or \$200 per semester whichever is less. You can move from the Player Squad to the Reserve Squad but no refunds of dues will be given. In the event you are on the Playing Squad and cannot make a game or games you will be asked to let someone else use your jersey, socks and shell.

I, the undersigned, have read and agree to comply with the terms of this *Player Contract*. I also understand that I can be removed from The Citadel Hockey Club Roster for breach of this contract.
